TO HAVE AND TO HOLD the same unto the District, its successors or assigns forever, and Grantor shall Warrant and Defend the sale of said property, goods and chattels hereby made unto the District, its successors and assigns, against all and every person or persons whomsoever.

THIS CONVEYANCE INCLUDES only those facilities and appurtenances that are intended to become part of the District System, and does not include service lines or any underdrains, storm drains or storm sewers, or any other drainage facilities or ways. The record drawing and other documentation showing the facilities and appurtenances included in this conveyance are on file in the District offices located at PO Box 690, Clark, Colorado 80428.

THIS CONVEYANCE AND ACCEPTANCE OF UTILITY LINES AND FACILITIES IS CONDITIONAL unless and until the District has executed the FINAL ACCEPTANCE hereinbelow. FINAL ACCEPTANCE is conditional upon compliance by the Grantor with the pertinent provisions of the District Rules and Regulations.

GRANTOR CERTIFIES that he has thoroughly reviewed all plans, notes and specifications, examined the project site and ascertained all soil, geological, ground water and other conditions to be encountered which might affect the construction and future maintenance of the project. GRANTOR ACKNOWLEGES that such plans and specifications have been prepared by or on behalf of Grantor, that the project is the responsibility of the Grantor, and that work is undertaken thereon only in reliance on Grantor's own investigation and information and not on any statements, representations or reports, if any, that may have been made or furnished by the District, its officers, agents or employees.
