## **Open Issues:**

- **1. August Minutes:** Jeff motions to approve as written, Suzy seconds, unanimous approval, motion carried.

- 3. Snowplowing HOA, Suzy The District is now named as an additional insured. Jackie has a copy of the paperwork that was sent from Kris and his insurance company. - 8. YVEA billing found out that Bob Hulton is still listed as primary contact for YVEA accounts. Jackie has reached out to YVEA member services to find out how to change this and then we are able to cancel service to the Doubek well that is decommissioned. We will then change the contact to Scott Colby's office.
- 9. Water items: Working on permits with/for Gilbert, have been working on several items with Scott.
  - A) On September 4<sup>th</sup> both pumps were installed and working properly at lift station.
  - B) He was tracking down locator to find a curb stop at 27080 Neptune
  - C) He wants to know how "serious" we are about shutting off water on Neptune because the curb stop is clogged; he was going to dig by hand and if it wasn't found, do we want to hire Subr to dig it up? (Hollis Hansen residence) waiting on update from hand digging.

- D) Just spoke to Scott and the dig at Hansen residence was not successful, how to proceed? The board discusses and Jim H. motions to lien property Suzy seconds, unanimous decision, motion carried.
- **10.** Scott asking for payment for \$400, submit bill? Suzy motions to pay Scott, Jeff second, unanimous decision, motion carried.
